

Invitation for prequalification of tenderers for Design, Construction and Operation of Kai Tak Sports Park

The Home Affairs Bureau today (April 28) invited prequalification of tenderers for the contract for Design, Construction and Operation of the Kai Tak Sports Park.

The scope of works of the contract comprises the design, construction and operation of the Kai Tak Sports Park of site area of about 28 hectares in the north apron of the former Hong Kong International Airport in Kai Tak, Kowloon City District. Facilities included in the project comprises a multi-purpose Main Stadium with a spectator capacity of around 50 000, a Public Sports Ground with a spectator capacity of around 5 000, an Indoor Sports Centre with a multi-purpose main arena with a seating capacity of 10 000 and an ancillary sports hall with a seating capacity of 500, retail and dining outlets with gross floor area (GFA) of about 60 000m², a bowling centre with 40 lanes, a health and wellness centre with GFA of about 2 500m², and Public Open Space of more than 8 hectares. The construction floor area is about 390 000m². Subject to funding approval of the Legislative Council Finance Committee of the Hong Kong Special Administrative Region, the contract is scheduled to commence in 2018 for a period of 25 years (including design, construction and operation period).
