**Questions relating to Kai Tak Sports Park project**

At the request of the Chairman of the Public Works Subcommittee (PWSC), we set out our response regarding the information required in the letter of Dr Hon Kwok Ka-ki of 15 May 2017.

Subject to funding approval of the Finance Committee, we plan to invite tenders for the Kai Tak Sports Park in the latter half of this year and expect to complete the evaluation in mid-2018 and enter into a contract with the successful bidder. We are preparing the tender documents and do not have the Design-Build-and-Operate (DBO) contract at this stage.

We will state clearly the monitoring regime, operating requirements, key performance indicators and performance bond clauses of the Kai Tak Sports Park in the tender documents and contract. Information on monitoring regime, operating requirements and key performance indicators are also set out in Appendix 2 of our supplementary information given to the Panel on Home Affairs on 4 May 2017 (LC Paper No. CB(2)1330/16-17(01)). Moreover, we have also explained in the Appendix of the supplementary information given to the PWSC on 16 May 2017 how the DBO approach would allow Government to have a high degree of control in Kai Tak Sports Park project for achieving objectives of the sports policy and meet the requirement of increasing vibrancy of the Sports Park.
